# **PART I: INTRODUCTION**

#### 1. VHS-DIVA Project:

The VHS-MSA DIVA Project, as part of its advocacy initiatives, is striving for policy level changes for TG/Hijra people in the entire country (except North East). The State of Tamil Nadu has celebrated Transgenders Day on 15<sup>th</sup> April every year. Although the Supreme Court Judgement on Third Gender was declared on 15<sup>th</sup> April 2014, the implementation of the Judgement for the welfare of TG/Hijra people is yet to be taken up in full swing.

#### 2. TG day background and milestones:

Transgender day was initially introduced in Tamil Nadu in 2005 by VHS. Positive past experiences enabled VHS-DIVA project to scale up TG day in the entire country in a phased manner. As a part of it, TG day was organized by the initiatives of VHS-DIVA project with the support of the CBOs, SACS, key stakeholders, NACO and other supportive organizations in six states during the last year.

The experiences gained through these TG day program in Tamil Nadu and in six states has enabled VHS-DIVA project to pilot and scale up to eighteen states in the country. During 2017-2018, the TG day program was organized in 13 states, to encourage participation of the TG community and allow for their mainstreaming into society.

Thus, DIVA Project this year, (2017) intends to advocate with the respective State Governments of 13 States (Tamil Nadu, Andhra Pradesh, Karnataka, Gujarat, West Bengal, Delhi, Uttar Pradesh, Uttarakhand, Punjab, Bihar, Chhattisgarh, Pondicherry) in collaboration with SACS/CBOs/Networks, to officially announce 15<sup>th</sup> April as Transgenders Day, emphasizing on the Supreme Court Judgement on Third Gender and also empowering communities to use this opportunity for advocating with Bureaucrats, Ministers, Policy-makers, etc., to bring policy-level changes for TG/Hijra people. Such an event will showcase community solidarity and help in mainstreaming of TG/Hijra people.

#### 3. TG day 2017 (importance, theme & key messages):

VHS-DIVA project conducted a "National level community consultation workshop on TG day" by involving CBOs, community consultants and program team to identify the theme of the TG day. Through a process, the team has arrived at on the following:

- Theme: Equal Rights & Mutual Respect
- Importance of the theme:
  - So far, on TG days, the focus was on awareness creation, image building, increasing public opinion, addressing myth & misconception, addressing stigma & discrimination, and other key aspects associated with the TGs. This year, the theme focuses on "Equal Rights & Mutual Respect".
  - "Equal Rights & Mutual Respect" emphasize on:
    - $\rightarrow$  Every transgender has equal rights like any other citizen.
    - $\rightarrow$  Transgender is also a citizen and has rights in all perspectives.
    - → Emphasizing on the rights of the TGs to empower and lead a healthy and happy life.
    - → Motivating TGs to know their rights and educating key stakeholders, general population and other organizations on the rights and expectations of the TGs, therefore enable them to understand and provide equal opportunities.
    - → By educating the entire community to understand the rights of the TGs and thereby encouraging them to provide equal opportunities, respect & recognition through existing and emerging opportunities.
    - → Developing positive attitude among TGs to respect the general population and to create a mutually respectful and enabling environment to lead a normal life.
    - $\rightarrow$  Developing positive image of the TGs in the society.
    - → To develop an action plan towards achieving equal rights and mutual respect at the intervention level, community level and at district & state level.
- **Proposed themes:** During the consultative meeting, the team members also suggested to consider the following themes in the upcoming years (i.e.,):
  - Networking & Partnerships
  - Lead to Lead
  - o Educate & Empower
  - Enabling Environment
  - Achieving 90-90-90


- Eliminating stigma & discrimination

It was also suggested we use the same theme for 2-3 consecutive years or use separate theme for every year, to enable CBOs to focus on achieving the desired goals and objectives.

#### 4. Planning and management of TG day program:

#### 4.1. Key stakeholders and their responsibilities:

VHS-DIVA project has identified the following key stakeholders in planning and organizing the TG day program in partnering states

- Building partnership with CBO for providing needed follow-up and guidance and other key activities.

- Formation of various committees for planning and conducting the program with the effective and efficient participation of community members at all levels.
- Conducting sub-group meetings at regular intervals for effective planning, reviewing and coordination.
- Advocacy with key stakeholders, inviting VIPs / celebrities / key officials for the program.
- Inviting community members, key stakeholders, press & media, supporters, etc.,
- Finalization of the place, stage and hall arrangements, developing agenda, printing of invitations, conducting TG day program, facilitating proceedings, sharing experiences in

the program, etc.,

- Facilitate opportunities for the community members to share their experiences and suggestions.
- Coordinating with VHS-DIVA project in effective planning and conduct of the meeting.
- Sharing feedback and suggestions to VHS-DIVA project.
- Sharing the program details for developing documentation.
- Engaging the committee members at every level for systematic planning, ensuring community participation, building the capacity of the community members in even management and enhancing ownership towards sustained initiatives.
- Conducting feedback and review meeting with the committee members.
- Developing follow-up plans based on the recommendation and suggestions emerged and overall coordination of the team for the program along with VHS-DIVA project team.

#### 4.2. Preparatory activities for conducting the TG day:

#### Preparatory activities at VHS-DIVA project:

- Project level consultation and developing Annual Action Plan.
- Planning and discussions with technical officers / program officers / in-charge of TG program along with activities proposed.
- Conducting Annual Action Plan meeting with SACS in the respective states and finalizing the activities plan.
- Developing concept note on TG day.
- Organizing a national workshop by involving the community members, community consultants, program personnel, experts and others to develop a plan for TG day.
- Sharing guidelines on conducting TG day.
- Designating a nodal officer / point of contact for providing technical support and conducting the TG day program.
- Conducting planning meeting at CBO level and evolving plans for conducting the TG day program.
- Finalization of the activity plan for each CBO and developing budget along with the financial guidelines.
- Developing master plan with activity & timelines for conducting the TG day in respective states.
- Identifying consultants for documenting the TG day program in the respective state and overall documentation of the program.
- Logistics coordination.

- Developing sample banners for CBOs to adopt and use across the country by ensuring the branding guidelines.
- Providing technical guidance.
- Developed and shared template on getting consent, oath taking, certificates, etc.,
- Internal review meetings among the nodal officers for sharing experiences, ensuring uniformity, introducing innovations, etc.,
- And other efforts to enable the CBO to organize the TG day program successfully.

Each committee is head by a convener and supported with 4-5 community members including peer educators and peers. The committee meets once a week for planning, reviewing, overcoming hurdles, introduce innovations, etc. The committees will also coordinate with other committees.

In addition to the sub-committees at CBO level, the CEO has formed an organizing committee which is headed by the CEO along with conveners of all the committees. This committee was useful in ensuring coordination among all, effective planning and successful conduct of the TG day program.

#### 6. Non-event based activities to coincide with TG day including use of social media:

VHS-DIVA project has undertaken various non-event based activities to coincide with the TG day for:

- To promote TG day and theme
- To elicit the support of the general population and stakeholders
- To enable the general population to understand the rights of TGs

- WhatsApp message developed and broadly shared (Annexure IV)
- To motivate and encourage general population to positively respond to TGs and respect

In this context, the VHS-DIVA project has developed the WhatsApp messages and sent to all key stakeholders, CBOs, TG networks, NGOs, FBOs, corporate, media and others. This has helped to reach out to larger population and enlist their support.

In addition to the social media, the project has also sent appeal letters to key stakeholders highlighting the significance of TG day and seeking their support. Further, the project has also shared the communication materials with rights of TGs for display and exhibition during the TG day function.

#### 7. Methodologies:

VHS-DIVA project has motivated and encouraged the CBOs to develop a one-day program by adopting participatory methodologies in celebrating TG day. In this regard, VHS-DIVA project has also shared different unique methodologies which can be adopted as a part of the TG day celebration to all CBOs. The respective CBOs reviewed the methodologies and evolved need based / state specific agenda by incorporating the important methodologies. Some of the methodologies adopted by the CBOs in conducting the TG day celebration may include but not limited to:

- Presentations
- Panel discussions
- Case study presentations
- Screening of video clippings
- Question and answer sessions
- Group discussions
- Presentation of charter of demands
- Experience sharing
- Recognition of TG leaders, supporters & mothers accepting their own child as TGs
- Celebration of Supreme Court Judgement
- Release of IEC materials
- Exhibition display of key activities for TGs & products developed by CBO, etc.,
- Oath taking
- Cultural program
- And other methodologies

#### 8. Participants of TG day:

The CBOs has taken initiative to invite the following participants based on the nature of the program, agenda and activities planned:

- Transgender / Hijra Communities
- Community leaders
- TG CBOs/Network representatives
- Special invitees preferably Bureaucrats, Ministers & Policy-makers
- Government departments particularly health, social welfare, rural, livelihood programs, judicial authorities, etc.,
- Elected body representatives including MPs, MLAs & Panchayat leaders
- Social institutions like Rotary / Lions club
- Corporates
- Autonomous organizations, academic institutions, human rights associations, NGO/CBO networks & funding organizations
- Political parties and senior level committee members

#### 9. Capacity building of CBOs for conducting TG day:

VHS-DIVA project has undertaken rigorous capacity building initiatives to build the capacity of the CBOs in planning, conducting & managing TG day program & other events. This capacity building initiatives was undertaken to develop knowledge and skills for effective management of TG day & other events. Some of the capacity building initiative will include but not limited to:

- Planning meeting and orientation to the CBO at the CBO level
- Guidelines on conducting the TG day
- Mentoring visits to the CBO by the project personnel
- Experience sharing between CBOs (those who has conducted during the phase I and plans to conduct in Phase II.
- Teleconference with the CBOs for providing guidance, clarifications, etc.,
- Sharing of last year TG day reports
- Designated nodal officer for systematic mentoring guidance and follow-up
- Training on event management for the CBO team
- And other need based support for building the capacity of CBOs

#### 10. Branding and visibility for the program:

VHS-DIVA project has taken utmost care in developing a sample template and design for developing a banner and using the branding guidelines in the invitation and other communication material. This has also had a provision to include the respective organizing agency name in the respective places for providing proper recognition. Based on this, all 17 CBOs has use the same design and maintain the branding guidelines in printing backdrop banners, display banners, invitations, communication materials, charter of demands, etc. This has helped in creating a better visibility for the project, establishing the TG day in a significant manner through media, etc.

#### 11. IEC materials and exhibition:

VHS-DIVA project has developed some of the display materials on rights of TG and on other themes. The same has also been shared with the respective CBOs for display. In addition, the respective CBOs has collected all the relevant IEC materials including advocacy materials, training materials, posters, etc., and displayed the same in the exhibition. In addition, the CBOs has also displayed the products produced by the TGs in their intervention areas. This exhibition has helped the officials, visitors, supporting stakeholders and others to understand the initiatives of the CBOs and evolving understanding to support in a strategic way.

#### 15. Documentation efforts by the CBO:

Each CBO has undertaken documentation efforts in the form of: registration and developing a database, photo video documentation, obtaining consent letters, database of media persons, documenting the press and media coverage details, charter of demands, etc. VHS-DIVA project has also engaged a state specific consultant for undertaking documentation and providing needed handholding to the CBO team in documentation. This has helped in improving the capacities of the CBOs in documentation and strengthening documentation system for other programs.

The above table and graph reveals the summary of the consolidation of the feedback received. The analysis on the feedback are given below:

 100% of the organizations expressed that, the theme proposed for TG day "Equal Rights & Mutual Respects" for the year 2017 is most agreeable. This denotes the CBOs are accepting the theme proposed for the current year, similar to the theme being suggested every year for World AIDS Day.

- The CBOs were encouraged to establish different sub-committees for carrying out specific functions in planning and conducting the event with the intention to build the capacity and ensure community ownership. Out of 17 CBOs, 77% opined as most agreeable and only 3% said as agreeable. Overall, almost all of them has agreed on the usefulness of the sub-committees established during this year.
- The TG day program encouraged the CBOs to collaborate with key stakeholders in the state level for enlisting their support. 70% opined that, it is most agreeable and 23% opined as agreeable. Overall, 93% of them have expressed that, this TG day program helped in bringing partnerships with key stakeholders in the state for availing support.
- As a part of the feedback, a question was asked on have your program objectives been met through this program. In response to this, 77% opined as most agree and 23% as agreeable. Overall, 100% of them has expressed that, this TG day program has achieved the program objectives.
- The CBOs were asked on have you gained more confidence in planning and managing the events and advocacy initiatives in the process of TG day. In response to this, almost 100% of them has expressed that, this has helped in gaining more confidence in planning and managing events and advocacy initiatives in future.
- 100% of the respondents (7 CBOs) who were involved conducting the TG day program during the last year and this year has informed that, they were able to manage and conduct the TG day program efficiently during this year.
- Overall, all of them are accepting that, they have plans for proposed follow-up activities on the charter of demands submitted during the TG day event by the CBO. 85% opined as most agreeable and 15% are agreeable.
- 100% of the organizations expressed that, the guidelines, circulars, communication sent by VHS-DIVA was useful in successful conduct of the TG day.
- 100% of the organizations / CBOs involved in conducting the TG day program has expressed that, overall satisfied with the conduct of TG day.

# PART III: CHALLENGES

The CBOs initially faced some of the challenges in planning and conducting the TG day program in the respective states:

- Delay in enlisting the support and engaging the state Govt. officials considering their ongoing priorities.
- The CBO was necessitated to advocate with higher level political leaders for sensitizing and engaging their political leaders / ministers in the program for getting positive responses.
- Identifying influential groups with the ruling Govt. in the respective state and engaging them in the process of advocacy and networking for influencing policies.
- Reaching Gharana leaders (Jamaths / Gurus) of TGs considering the richness, seniority and higher level members.
- Engaging national leaders in the TG day program considering the state level event.

VHS-DIVA project and CBO has jointly evolved plans to address the above challenges during the planning process and addressed the common state specific challenges. These efforts have also helped the respective CBOs to gain skills and confidence to undertake systematic advocacy efforts at higher level for engaging and availing their support.

#### At CBO level:

- Formation of follow-up committees to initiate actions on the recommendations evolved and commitments made by the supportive key stakeholders.
- Developing a database of all media personnel who has participated in the TG day program and other media personnel whose supportive for the health programs. The capacitated CBOs will share case studies, experiences, press briefs and other information at regular intervals to enable them to write positive articles for influencing policy changes.
- Mentoring the CBO team to undertake follow-up activities with their respective key stakeholders to operationalize the commitments / recommendations evolved in the program.
- Encourage CBOs to interface with other CBOs for sharing experiences, clarifications and encouraging peer group learning.
- Encourage to include new members in the various committees to provide opportunities to undergo practical experiences and build their capacities in organizing the events.
- Encourage the CBO team to undertake advocacy and network with the local Govt., policy makers and influential groups for introducing TG day on 15<sup>th</sup> April, introducing policies and program for the benefit of TGs.
- Extend all possible support to achieve 90:90:90.
- Encourage the peer educators and community members who is continued to contribute for the development of TGs by recognizing during monthly meetings, peer education conventions and special meetings.

#### At Project level:

- Organizing a national level workshop to identify the challenges in the ongoing program for the TGs and possible innovations for piloting.
- Developing Learning Sites for piloting innovations to empower TGs.
- Developing a WhatsApp group among all CBOs involved in intervention among TGs for technical update, experience sharing and providing opportunities for clarifications.
- Communication and follow-up with NACO for declaring TG day at national level with the support of key stakeholder at state and national level.
- Exploring the possibilities to establish a National Resource Centre for TGs to undertake activities such as: capacity building, technical update, knowledge exchange, repository, advocacy and other initiatives.

- Planning and conducting a training on effective planning and management of events for the CBOs by providing hands-on experiences in a demonstration event. This will help each CBO to acquaint knowledge and skills for effective conduct of events.
- The designated nodal officer from the project will continue to extend needed technical assistance, provide guidance, mentoring and need based support to enable them to perform better and scale-up activities.
- Facilitate experience sharing cum review meeting among the nodal officers to mutually gain experiences and mentor the respective CBOs based on the experiences gained through cross learning.
- Document the TG day report and disseminate the same with NACO, SACS and other key stakeholders.
- Facilitate special programs in TV channels to highlight the community members' needs and expectations from the Govt. for influencing policy makers.
- Develop theme and key messages for each TG day for the upcoming years to communicate gradually and consistently.
- Exploring on the possibilities to provide strategic guidance and capacity building to the CBOs on advocacy, building partnerships and resource mobilization.

# PART VI: FOLLOW-UP PLANS

After the TG day program, VHS-DIVA project and CBO team had a joint meeting for reviewing the TG day program and developed follow-up plans for undertaking follow-up initiatives on the suggestions, commitments and recommendations evolved during the meeting. Some of the efforts for follow-up will include:

- Each NGO/CBO developed a follow-up plan with timelines:
  - Designated 1-point person for each of the follow-up activity to ensure systematic follow-up and accountability. To support this nodal person / point person, a committee has also been constituted to undertake coordinated efforts.
  - Developed bi-monthly internal review mechanism to understand the progress, support needed and follow-up plans.
- The NGO/CBO will submit monthly report on the progress and the status to VHS-DIVA project in the prescribed format.
- One nodal officer from VHS-DIVA project has been designated for each CBO for the following purpose:
  - To provide needed strategic support and mentoring.
  - $\circ$   $\,$  To extend needed technical guidance for overcoming the challenges.
  - To review and provide feedback on the report submitted.
  - To develop a comprehensive plan to achieve the planned recommendations / commitments.
- Advocacy initiatives with higher level policy makers, meeting with ministers, bureaucrats, influential groups, media, etc., for introducing policies, programs, schemes, etc., based on the commitments evolved during the TG day program.
- Facilitating experience sharing meetings between the CBOs for handholding and mentoring to work with the system and introducing policies, programs, schemes, etc. This process will help the CBOs to learn from other CBOs based on the state experiences. In case, if one state has already introduced a policy, scheme, guidelines, etc., if other state is interested in replicating or adopting, the experience sharing will help in this process.
- VHS-DIVA project program team will provide need based technical assistance for developing concept notes, guidelines, etc., for introducing new programs. In addition, the program team will review and provide suggestions on the documents developed by the CBOs in this process.
- VHS-DIVA project will provide virtual support for motivating the CBOs to undertake follow-up.

- VHS-DIVA project will provide ongoing mentoring and need based strategic support.
- The SACS and TSUs are provided with the follow-up action plans and the CBOs and SACS will work together in advocating with different development departments.
- The CBOs will undertake series of activities throughout the year focusing on "Equal Rights & Mutual Respect".
- The CBOs planned to engage the similar CBOs and their networks in enlisting the support from the Govt., private sector, civil societies, FBOs and other key stakeholders for empowering TGs.

## **PART VII: LEVERAGING OF RESOURCES**

VHS-DIVA project has emphasized and encouraged the CBOs to integrate the process of leveraging of resources in planning and management of TG day program. In this regard, the CBOs were also provided with needed guidance and support by the concern nodal officers. In line with this, the CBOs has taken efforts for undertaking advocacy, developing partnerships, leveraging support either for the TG day or for the future programs to lead a sustainable community led interventions. Some of the leverages undertaken by the CBOs will include:

# PART VIII: LEARNINGS

Through the process of organizing TG day program by 17 CBOs spread over in the entire country, VHS-DIVA project has identified the following learnings:

- Developing theme for TG day is very much important for communicating key messages in a focused manner.
- Advocating and engaging supportive stakeholders is very much important.
- Formation of sub-committees at CBO level has developed greater participation, contribution, coordination and ownership.
- Guidelines for organizing TG day, resource materials on planning and management of events and other resource materials supported with capacity building and mentoring enables the CBO to organize the program more efficiently and effectively.
- Capacity building of CBO office bearers and community members are equally important for institutionalizing, strengthening systems and undertaking sustained initiatives.
- Mapping of media personnel, meeting in person and sensitizing, providing media brief, communicating with the media in a positive mode and rigorous follow-up found effective to get continuous support in publishing articles and media coverage to influence policies.
- Branding the TG day with themes is more effective in achieving the specific objectives and work towards common goals.

## PART IX: EXPECTED OUTCOME:

- Advocacy contributing for policy level decisions at the State levels. It helps in mobilizing
  public support and advocate for policy changes at the states for welfare of TG/Hijra
  people.
- Memorandum submitted by Community to the top level policy-makers for recognizing April 15th as Transgender Day and for implementing Supreme Court Judgement on Third Gender.
